

## Village at Worthington Civic Association Meeting Wednesday, March 26, 2025

# Monthly Meeting Minutes

The meeting was held via Zoom.

- Members present: Nick Sisco, Dora Sisco, Chris Zircher, Kay Biggs, Richer Malboeuf, Angie Gerding, Becky Brown-Hallowell, Mary Lykens, Jeff Lykens
- Nick Sisco called the meeting to order at 7:00 PM. A motion was made to approve the previous meeting minutes. The motion was seconded and approved.

#### Treasurer Report/Dues Report – Jeff Lykens

Jeff Lykens reported a checking balance of \$11,318.90. He also suggested we close out the Business Relationship savings account, which has \$693.91. The group discussed and all felt it was OK to close this account. Jeff also decided to cancel the Quicken subscription as he does not use it.

Jeff mailed out 79 letters, which cost a total of \$269.87 for postage, letters, envelopes and printing. We collected 13 dues from this effort and a total of \$540.00.

#### Landscape Committee – Mary Lykens

Mary obtained 2 quotes. She mentioned that last year we spent \$1,139 on spring cleanup, mulch, edging and flowers. She obtained a quote of \$1,234 from J&G as well as another quote, which totaled around \$2,000. The group discussed and decided to go with J&G this year. Mary also discussed planting arborvitaes. A motion was made, seconded and approved to allow up to \$3,000 for landscaping this year, including planting of arborvitaes.

J&G also provided an estimate for lawn mowing. The cost is \$96 per mow, which covers both the Leaview and Brownsfell areas. They are estimating around 28 mows for a total of \$2,688.

### Welcome Committee – Chris Zircher

There were no recent sales in this neighborhood on the Franklin county website, however we believe there will be new residents at Leaview, Pampas Court and Prairieview. New residents to be confirmed and will receive a Welcome Bag.

## Social Committee – Mary Lykens/Dora Sisco
